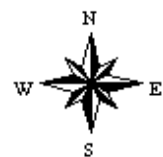
Aerial Map - Surveyed Acres

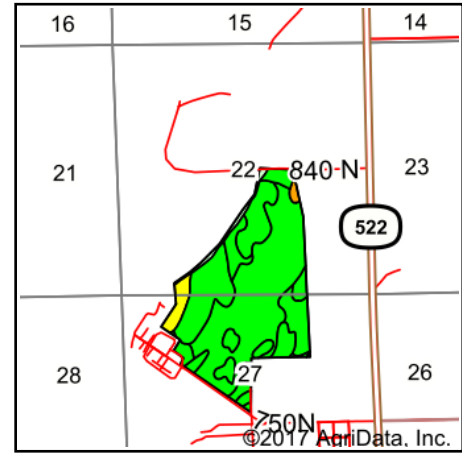

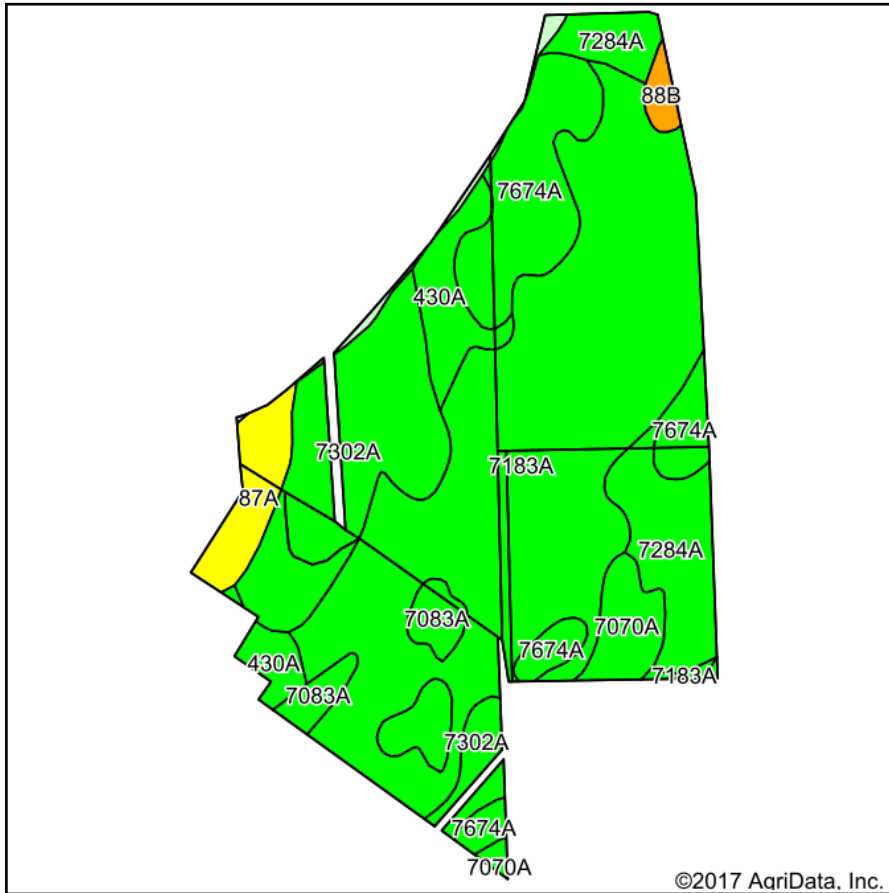

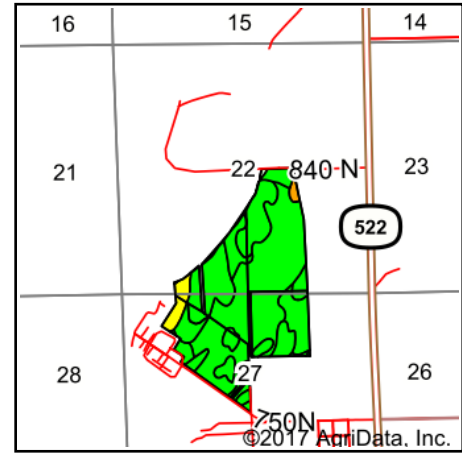

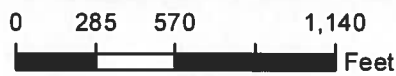

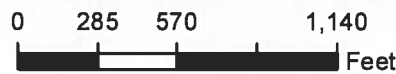
