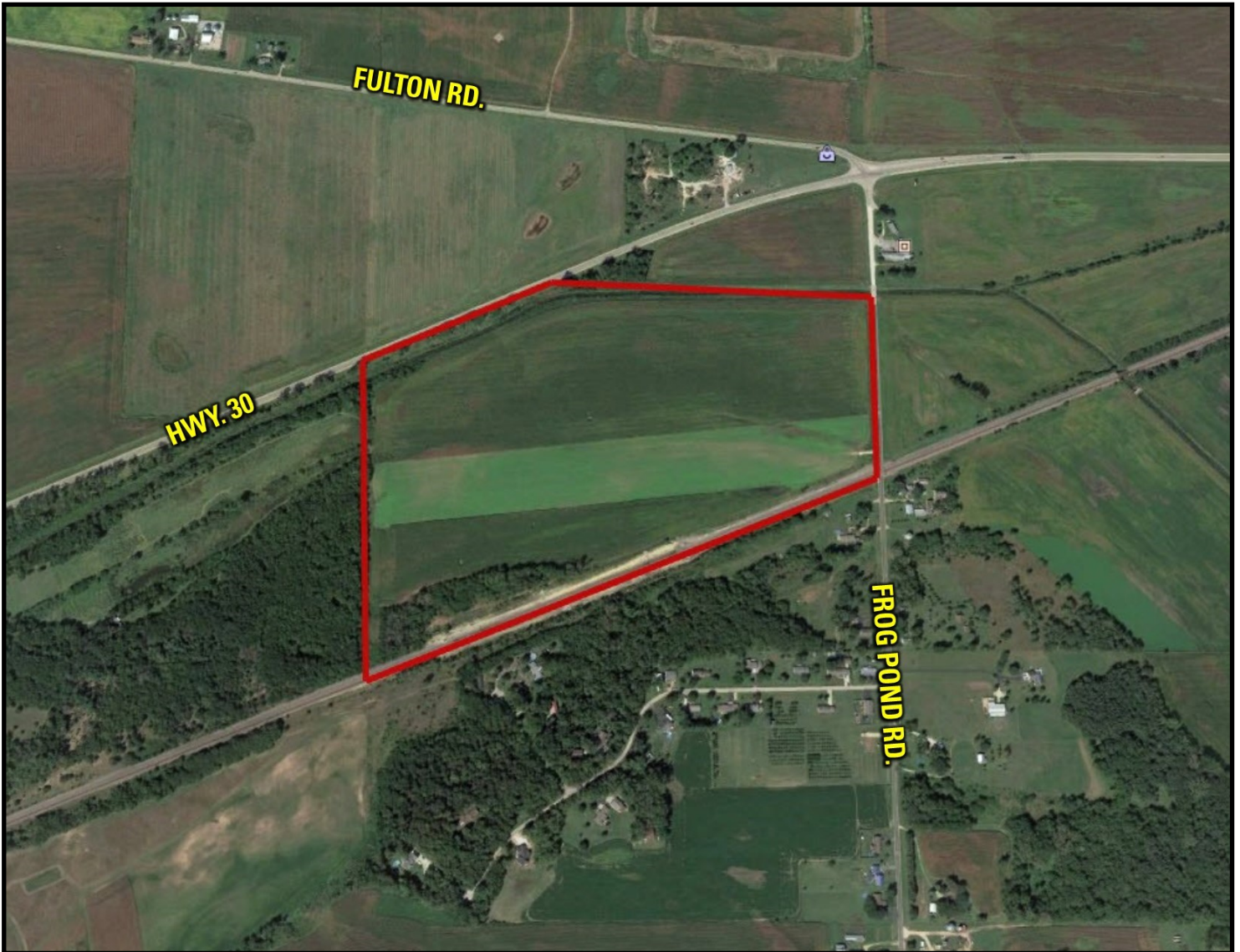

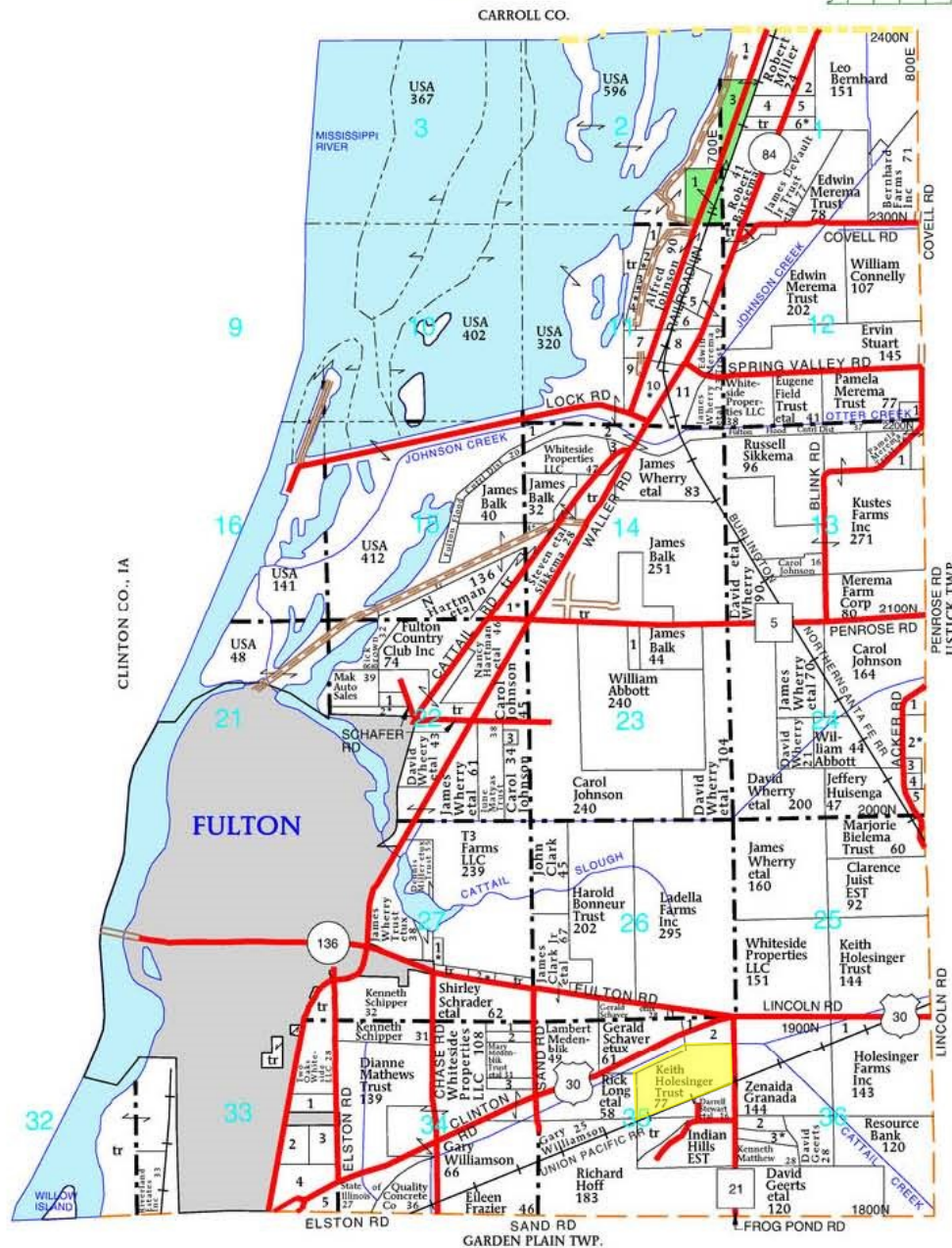

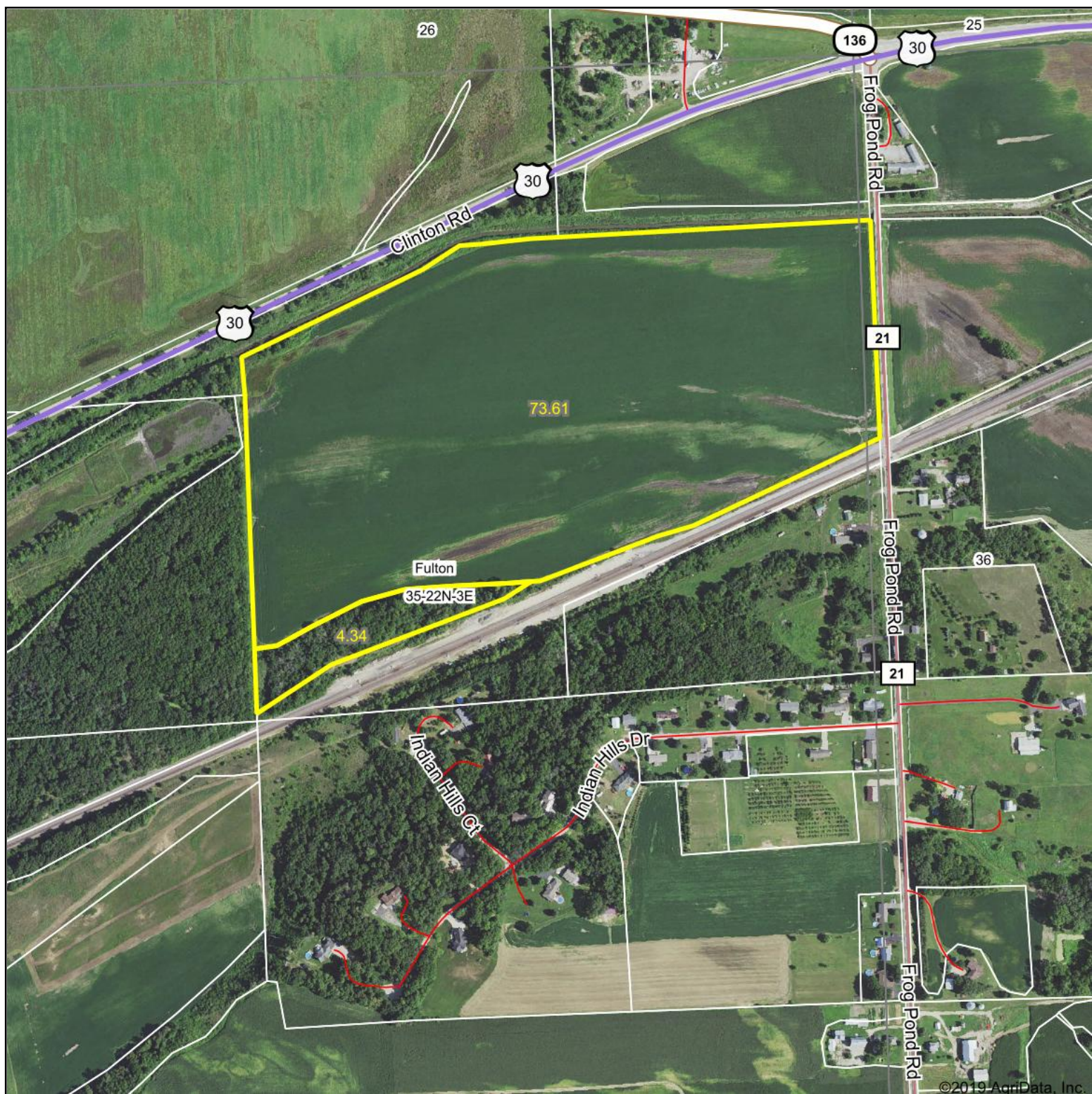

Aerial Map - Total Acres per Whiteside Co. FSA



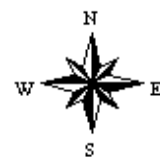

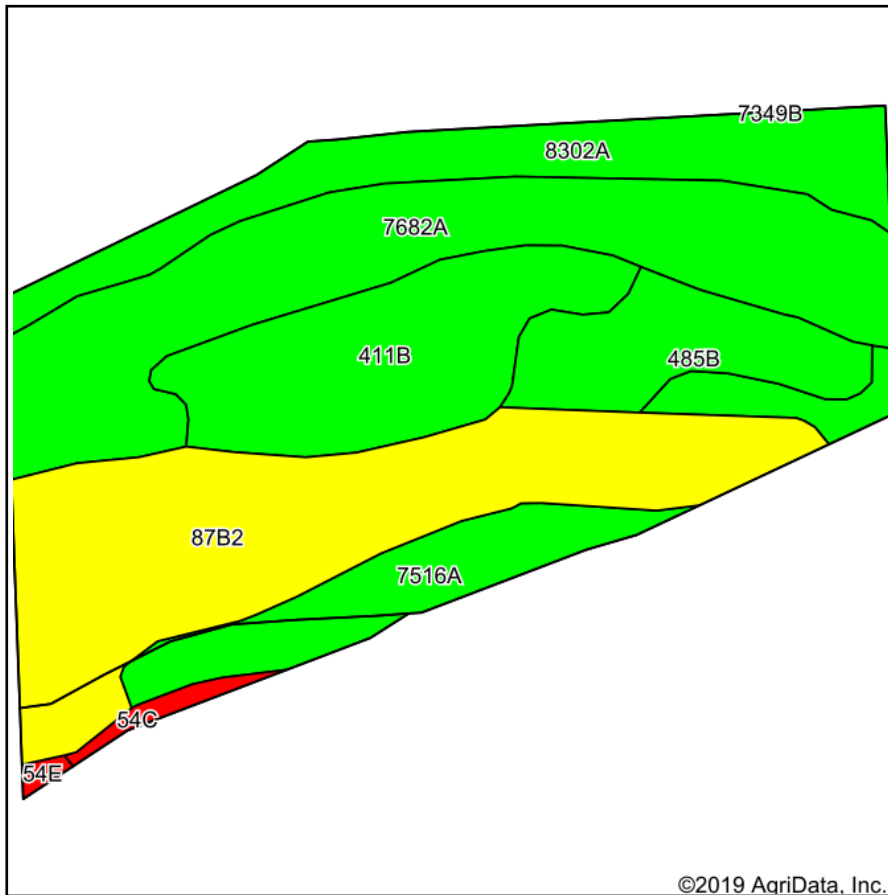

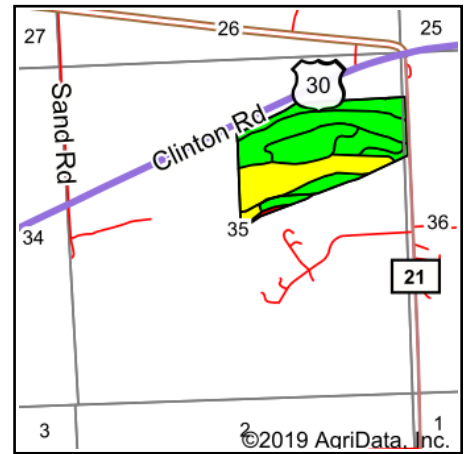

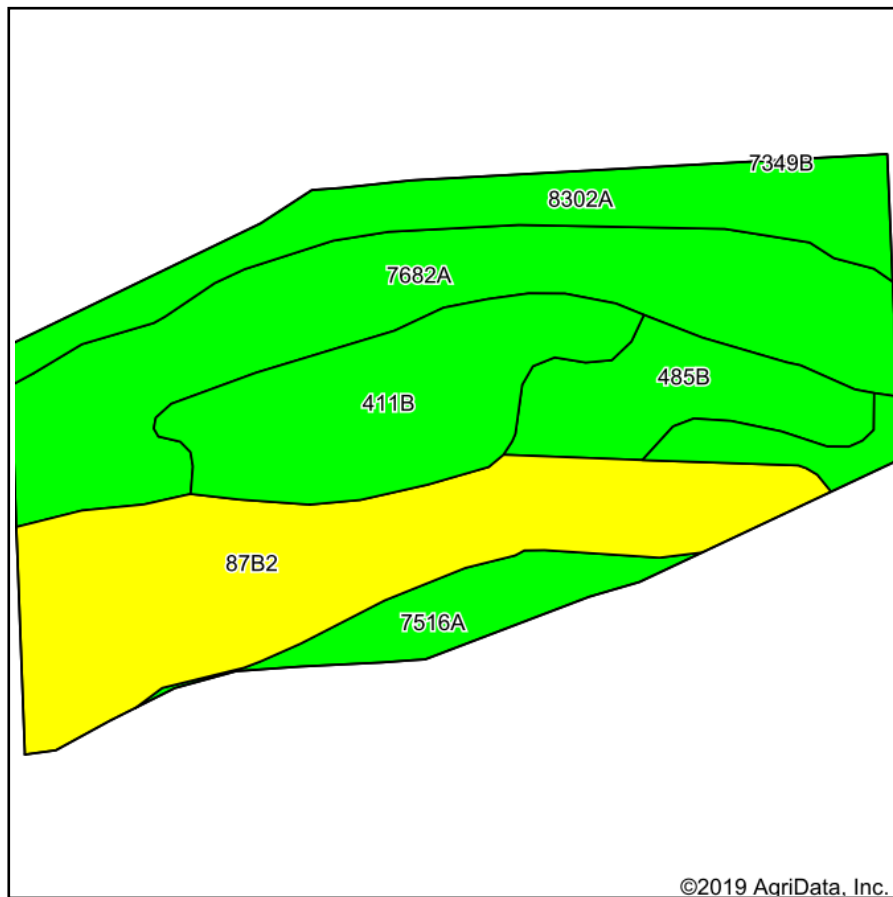

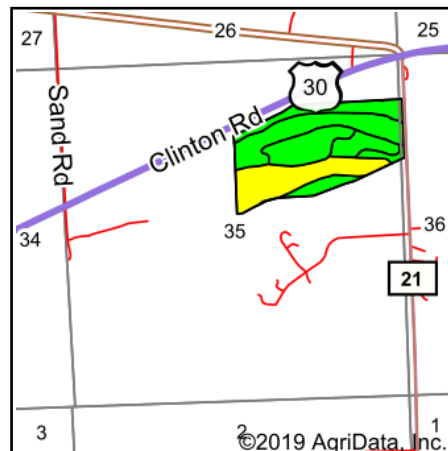

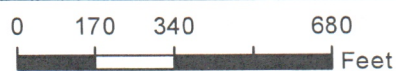
