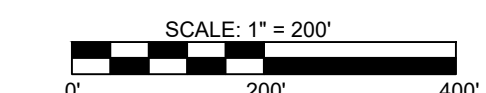

DESCRIPTION:

PARCEL #1:

LOCATED IN THE SOUTHEAST QUARTER (SE1/4) OF THE SOUTHEAST QUARTER (SE1/4) OF SECTION 15, THE NORTHEAST QUARTER (NE1/4) OF THE NORTHEAST QUARTER (NE1/4), THE SOUTHEAST QUARTER (SE1/4) OF THE NORTHEAST QUARTER (NE1/4) OF SECTION 22 AND THE WEST ONE-HALF (W1/2) OF THE NORTHWEST QUARTER (NW1/4) OF SECTION 23 OF TOWNSHIP THREE NORTH (T3N), RANGE ONE WEST (R1W) OF THE FOURTH PRINCIPAL MERIDIAN, CITY AND TOWN OF PLATTEVILLE, GRANT COUNTY, WISCONSIN, CONTAINING 60.76 ACRES, MORE OR LESS, AND BEING DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST (NE) CORNER OF SAID SECTION TWENTY-TWO (22) AND THE POINT OF BEGINNING;

THENCE NORTH 49°29'50" WEST 1,229.37 FEET ALONG THE NORTHEASTERLY LINE OF LOT #1 OF CERTIFIED SURVEY MAP NO. 761 RECORDED AS DOCUMENT NO. 627004 TO THE NORTHERLY CORNER THEREOF;

THENCE SOUTH 31°08'01" WEST 224.01 FEET ALONG THE NORTHWESTERLY LINE OF SAID LOT #1 TO THE NORTHERLY LINE OF A PARCEL OF LAND ASSESSED TO RICHARD AND JUDIE BELLMEYER AS DESCRIBED IN DOCUMENT NO. 682323;

THENCE NORTH 44°56'56" WEST 166.05 FEET ALONG THE NORTHERLY LINE OF SAID PARCEL;

THENCE NORTH 60°56'56" WEST 132.00 FEET ALONG THE NORTHERLY LINE OF SAID PARCEL TO THE WEST LINE OF THE NORTHEAST QUARTER (NE1/4) OF THE NORTHEAST QUARTER (NE1/4) OF SECTION TWENTY-TWO (22);

THENCE 622.80 FEET ALONG THE ARC OF A CURVE CONCAVE TO THE NORTH, HAVING A RADIUS OF 1,066.74 FEET, A CENTRAL ANGLE OF 33°27'05", AND A CHORD BEARING AND DISTANCE OF S 59°14'15" E 613.99 FEET ALONG THE SOUTHERLY RIGHT-OF-WAY OF THE FORMER CHICAGO AND NORTHWEST RAILROAD;

COMMENCING AT THE WEST QUARTER (W1/4) CORNER OF SAID SECTION TWENTY-THREE (23);
