The farm consists of 216.76± total acres with 172.43 FSA cropland acres. The tillable soils boast an NCCPI value of 46.6 with the primary soil types being Dodgeville, Edmund, and Newglarus silt loam. With long straight rows, rich soils, and great hard-surfaced road access off County Road C and Grossen Road, this farm would make for a great add-on to an existing farming operation.

The home and multiple outbuildings are perfectly situated overlooking the northern portion of the farm just off County Road C. The upper level of the 1,782 square foot ranch style home features three bedrooms, and two full baths, with an open floor plan and a two-car attached garage. There are two machine sheds that both measure 60' x 40'. The old milking barn has fallen down and is non-usable. The home and all outbuildings will be sold "as-is" "where-is".

The central portion of the farm has excellent hunting opportunities where several Boone & Crockett class Whitetails have been harvested over the years. The heavily timbered draws create multiple pinch points that would make for exceptional bowhunting spots. There are also numerous places to erect an elevated tower stand to overlook the property. You'll also find thousands of Black Walnut trees varying in age throughout the property. One could plan to harvest the trees once they reach maturity or let them grow and enjoy their true beauty in their natural setting.















DIRECTIONS
