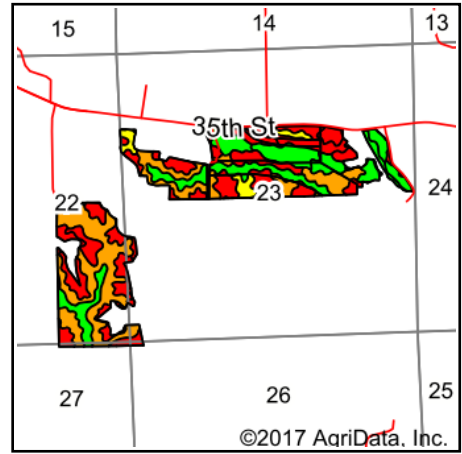
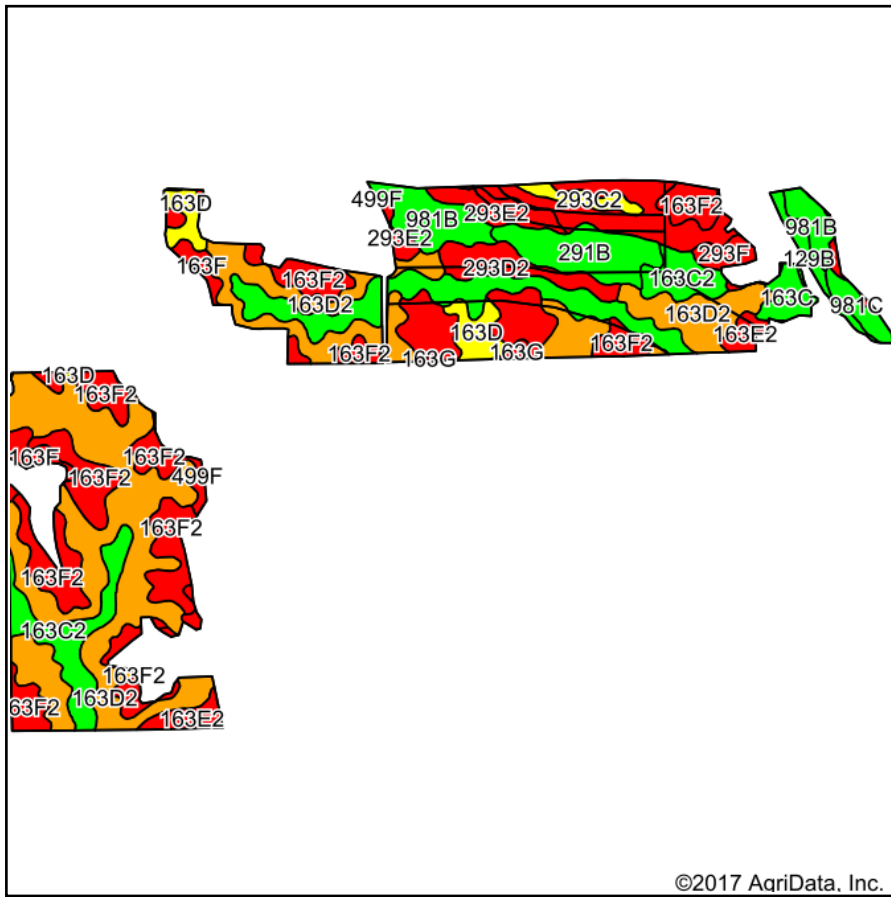


Soils Map - Tillable Acres
