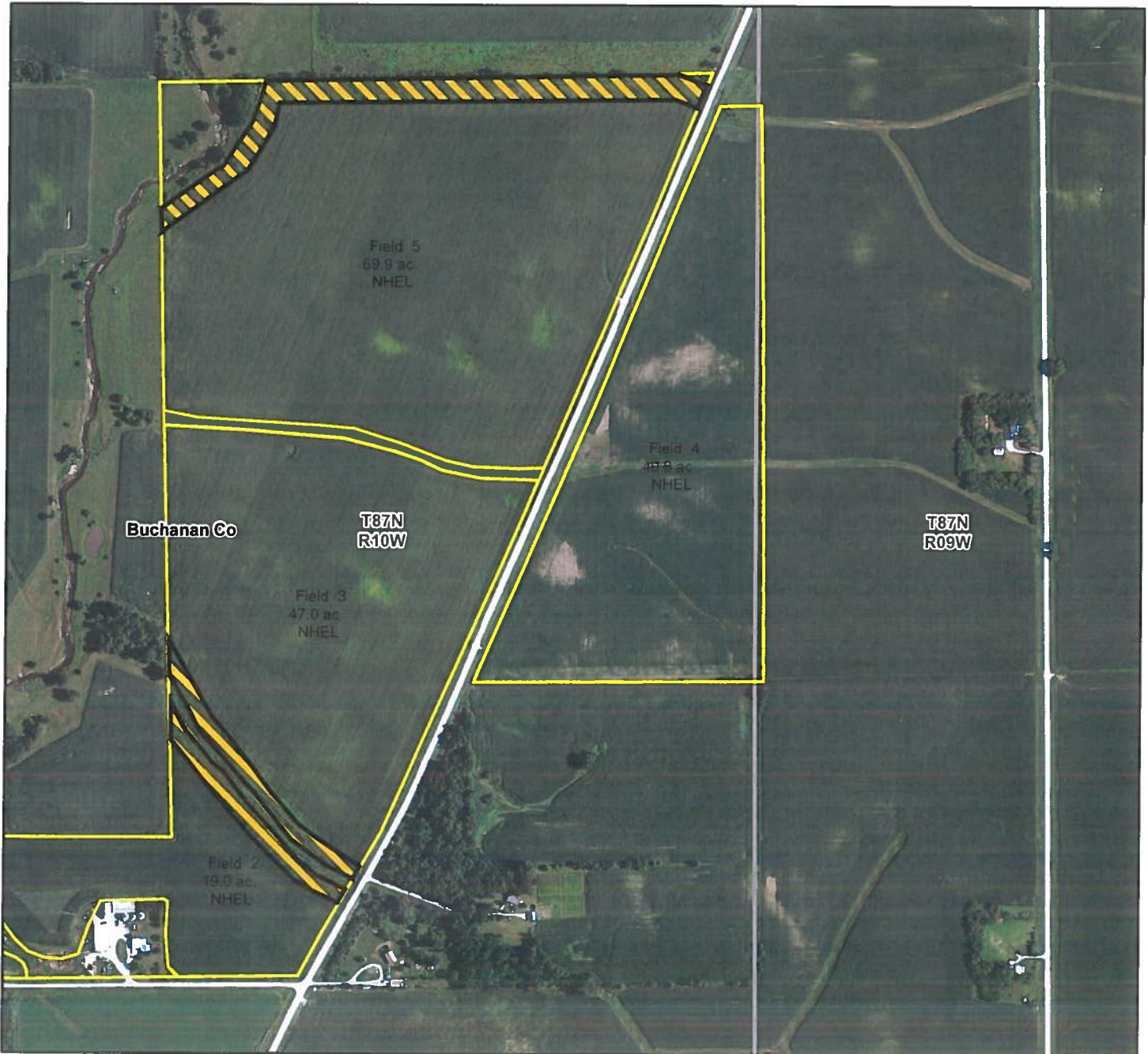
Conservation Plan Map
